Executive Committee Members Draper, DeFrank, Woodruff and Ashbery:

As a registered Republican, I respectfully request the Orleans County Republican Committee (OC-GOP) conduct a hearing into the Ridgeway Republican Committee (RW-GOP) for disloyalty to the party and corruption relating to the committee's endorsements of February 9, 2019.

Officers and members of the Ridgeway GOP violated the RW-GOP bylaws, which were adopted in whole from the OC-GOP bylaws. The town committee is in violation of the OC-GOP charter. Actions by officers and members are also in breach of New York Election Law and Civil Service Law.

As the charges pertain to the RW-GOP chairperson, the vice-chair/secretary and members of the committee, it is incumbent upon the OC-GOP to conduct a hearing. It would be unsuitable for RW-GOP officers to appoint town members to a subcommittee in this matter. The OC-GOP charter outlines a town committee may not engage in practices that conflict with the bylaws of the county committee, NY Election Law or other laws. Under Article 2 of NY Election Law, a county committee has the ability to remove (town) members.

Please inform as to the proceedings so that we may transmit the related documents for the committee /sub-committee to review in advance. Thank you for your time and assistance with this matter.
